A Glimpse of Important Events for South Carolina Engineers

QUALIFICATION BASED SELECTION FOR ENGINEERS AND SURVEYORS



Rep. Kenny Bingham, PE, and Rep. Nelson Hardwick, PE, recently introduced legislation (H.4429) to strengthen the qualification based selection process for public work. For years, engineers and surveyors have complained that many political subdivisions have continued to bid (ask for price) engineering and surveying services with disregard for state and federal procurement laws that require qualification based selection for public work, if federal or state funds are used on projects. This legislation, if passed, will make the submission of a bid for public work an infraction of the engineer who submitted the bid.

Since the end of the legislative session is upon us, it is unlikely that there will be movement on this bill until next year. However, this gives us a great opportunity to evaluate the bill, determine the components of it which we support and those which we don't, and contact our representatives and senators, and help them develop this bill in a manner that will strengthen our profession.

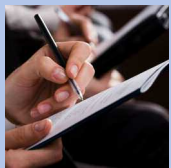

ASCE P.E. Exam Review Course



The South Carolina Section is pleased to offer ASCE's live web-based P.E. Civil Exam Review Course. Taught by a team of experienced P.E. Exam Review instructors, the course will be presented as a series of 15 two-hour modules held from Aug 24-Oct 7. The sessions include 12 topics covering the breadth section of the exam including: structural analysis, strength of materials, geometric design, concrete design, soil mechanics, foundation engineering, hydraulics, hydrology, steel design, water/wastewater treatment, construction materials, & construction management.

The review also includes 3 topics covering the depth section of the exam: water resources, traffic engineering & geotechnical engineering. These sessions are designed to provide you with focused and deeper knowledge that you need in each subject area.

This review course will focus on:

- Topics and material that have a high probability of being included on the exam based on instructor knowledge and opinion
- Solving practice problems and providing immediate feedback ASCE's P.E. Civil Exam

The sessions are Tuesday/Thursday from 3:00 PM to 5:00 PM from Aug. 24-Sept. 30. The October 5-7 sessions are Tuesday/Wednesday/Thursday from 3:00 PM to 5:00 PM. Cost is \$200/person.

Locations are Columbia — Midlands Tech NE Campus, Charleston — The Citadel, and Myrtle Beach: TBD.

Please note a minimum of 8 registrants per location is required. Other locations may be considered if at least 8 registrants are provided at a location can be secured. ASCE membership is NOT required to take the course.

ASCE Bridge Competition Raises the Roof



The 2010 Bridge Competition, held on April 24th was a smashing success. The testing was the culmination of an

intensive study, design and team construction of popsicle-stick bridges. Philip Barr, a testing device operator, shared, "this has been a blast. Every time I bring out a new bridge, the crowd goes wild! I felt like a rock star!"

The event played host to 280 popsicle-stick bridges built by 800 Greenville County fourth grade students. The bridges were load tested up to 100 lbs. Then, the bridges were evaluated using a strength to weight ratio. When the numbers settled out, the average bridge weighed a mere 0.33 lbs but was able to support up to 65 lbs, an average strength to weight ratio of 195. And, 45 of the 281 bridges (16%) were able to carry the full 100 lbs. Branch President, Tom Hill, shared, "it's clear that these children took the project very seriously and really poured their hearts into the effort. We were in the presence of our future engineers today."

ASCE-SC would like to extend a special "thank you" to Tom Hill, Bill Phelan, Jennifer Mustar, and Trip Ford for their efforts in making this event a success.

Citadel Receives ASCE Distinguished Chapter Award

The Citadel ASCE Student Chapter has been awarded the 2010 Region 4 Distinguished Chapter Award by the ASCE Educational Activities Committee. This award is made annually to the most outstanding Student Organization in the region. The Citadel Student Chapter was also one of nine Robert Ridgway Award Finalist this year.
